ORDER:

In the Government Order first read above, the Government have issued orders approving the proposal of the Commissioner of Archaeology for declaring Udayagiri Fort Wall and Dellanoy Tombs at Padmanabhapuram Town, Kalkulam Taluk, Kanniyakumari District, as a protected monuments and the Notification for Publication in the Tamil Nadu Government Gazette inviting objections and suggestions in regard to the above monuments as a protected one as required under sub section (1) of section-3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966. 2. Now the Commissioner of Archaeology has submitted a revised proposal stating that due to patent error in the total extent and revenue survey number corrected, a revised notification for this effect has to be issued under section 36 of the above said Act.
