In the Government order first read above the government issued notification declaring the Thirumalai Naicker Mahal at Madurai as an Ancient monument for protection and preservation under section 3(1) of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966. (Tamil Nadu Act 25 of 1966) As no objection has been received before the expiry period of two months from the date of notification the Director of Archaeology has requested the Government to declare by a notification under sub-section(3) of section 3 of the said Act that the "Thirumalai Naicker Mahal" at Madurai as a protected monument. The Government accept the suggestion of the Director of Archaeology.

2. The following Notification will be published in the Tamilnadu Government Gazette:

### NOTIFICATION

In exercise of the powers conferred by sub-section (3) of section 3 of the Tamil Nadu Ancient and Historical Monuments and the Archaeological Sites and Remains Act, 1966, the Governor of Tamil Nadu hereby declares that the Thirumalai Naicker Mahal at Madurai, the details of which are specified in the schedule below be a protected monument.
