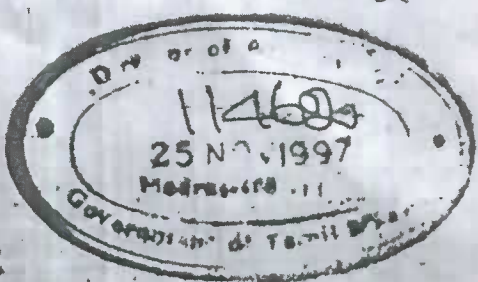

ORDER

In the Government Order first read above a notification was approved inviting objections and suggestions for declaring the Jagadevi Fort, Jagadevi Palayam Village, Krishnagiri Taluk, Dharmapuri District as an Archaeological Site and Remains under sub section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966 (Tamil Nadu Act 25 of 1966). No objection or suggestion has been received either by the Government or by the Director of Archaeology, Chennai. The Director of Archaeology in his letter second read above has therefore requested the Government to issue notification declaring the above said archaeological site and remains as a 'Protected Monument' under subsection (3) of section 3 of the said Act.

2. The Director of Archaeology, Chennai, has accordingly submitted a draft notification under sub section (3) of section 3 of the said Act. The Government accept the proposal of the Director of Archaeology and approve the draft notification submitted by him.

3. The notification appended to his order will be published in the Tamil Nadu Government Gazette.

4. The Works Manager, Government Central Press, Chennai-600079 is requested to publish the notification appended to this order in the next issue of the Tamil Nadu Government Gazette and send 5 copies of the Gazette notification each to Government and the Director of Archaeology, Chennai-600 113.
