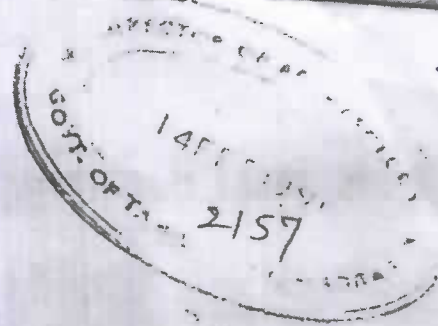

ORDER:

In the Government Order read above the Government issued Orders approving the proposal of the Director of Archaeology Department for declaring Marudu Pandian Fort at Aranmanai Siruvayal Village, Karaikudi Taluk, Pasumpon Devar Thirumagan District as a protected monument and the notification for publication in the Tamil Nadu Government Gazette inviting objections and suggestions regard the above monument as a protected are as required under sub section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act 1966 (Tamil Nadu Act XXV 1966). No objection or suggestion has been received either by the Government or by the Director of Archaeology Department, Madras. The Director of Archaeology Department has therefore requested the Government to issue Notification declaring the aforesaid monument as a 'protected monument' under sub-section (3) of section 3 of the said Act and has submitted a draft notification accordingly.

2. The Government approve the proposal of the Director of Archaeology Department and approve the draft notification submitted by him.

3. The notification annexed to this order will be published in the Tamil Nadu Government Gazette. The Works Manager, Government Press, Madras is requested to supply 5 copies of the Gazette Notification as published in the Tamil Nadu Government Gazette to the Director of Archaeology Department.
