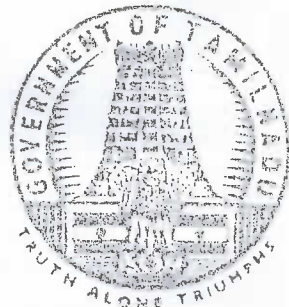

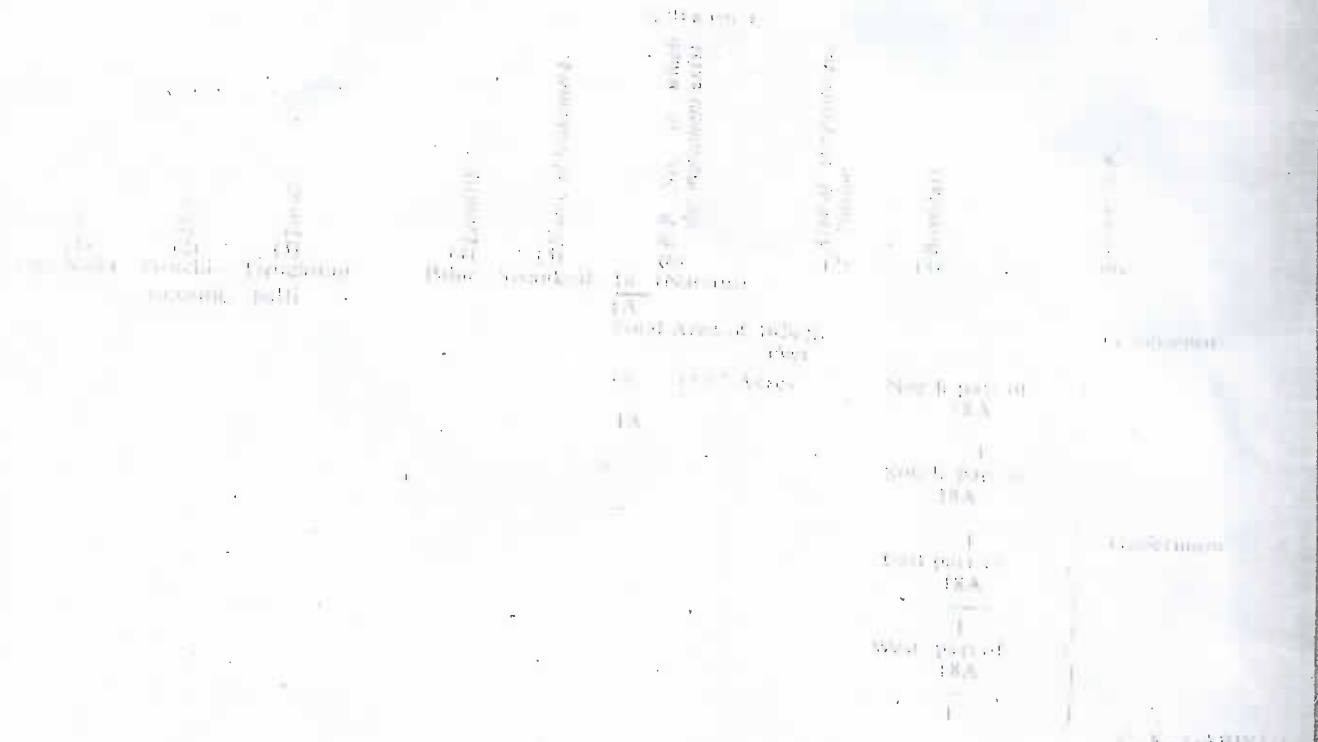

RESERVATION OF KATTUR FOREST BLOCK IN TIRUCHIRAPPALLI DISTRICT AS RESERVED FOREST.

 In exercise of the powers conferred by section 16 of the Tamil Nadu Forest Act, 1982 (Tamil Nadu Act V of 1982), the Governor of Tamil Nadu hereby declares the area, the boundaries of which are specified in the schedule below as reserved forest with effect on and from the 23rd June 1980.

SCHEDULE

Reserved Forest, Madurai taluk, S.P. No. 12, Kattur Village
 S.P. No. 2/1 - 270.16 acres
 Name of the forest block—Kattur
 Area of the forest block—270.16 acres (or) 109.13 hectares.

Boundaries

The block comprises the whole of S.P. No. 2/1 in S.P. No. 12 village and bounded by

North and east—Starting from the north-eastern corner of S.P. No. 1 (Eastern corner) of No. 12, Kattur village then in line the north-western corner of the block, the boundary runs generally towards east and south along the common village boundary between the said Kattur village and S.P. No. 2/1.

South—Thence the boundary runs generally west along the part of eastern and northern side of S.P. No. 2/1, part of eastern, northern and western side of S.P. No. 2/1, part of northern side of S.P. No. 5, northern side of S.P. No. 4, all of the said Kattur village to its northern corner.

West—Thence the boundary runs generally west north along the eastern side of S.P. No. 1 (Corner) of the said Kattur village to the starting point.

Rights admitted—1. Pathway at 20 links (4 metres) and 25 links (11 metres) length on the southern side of the forest block, 30 links (6 metres) west from the junction point of S.P. Nos. 2, 4 and 5 connecting the patta land of S.P. No. 2/2 across the forest block in S.P. No. 2/1 admitted.

2. Right of way to all points through the Upper forest which runs across the forest block is admitted.

3. Patta land measuring 1.80 acres (0.73 hectares) land measurement.
