Notice is hereby given that the proposal shall be taken up for consideration on or after the date of expiry of two months from the date of publication of this Notification in the Tamil Nadu Government Gazette, and that any objection or suggestion, which may be received with respect thereto from any person before the date of expiry will be considered by the Government of Tamil Nadu.
