In their order read above, the Government in public Works Department have transferred the entire Thanjavur Palace buildings, Thanjavur to the Department of Archaeology from the control of Public Works department, for protection, preservation and maintenance by the State Department of Archaeology under the Tamil Nadu Ancient and Historical Monuments and Archaeological Remains Act 1966. The Director of Archaeology, Madras has accordingly submitted a draft notification under section 3 (3) of the said Act and requested the Government to approve and publish in the Tamil Nadu Government Gazette.
