ORDER:

In the Government Order read above orders were issued declaring the cave temple and sculptures at Chinna Ivar Malai, Thathanayakkanpatti Village, Palani Taluk, Anna District as a protected monument and the adjoining areas as a prohibited area. Notification were also published in the Tamil Nadu Government Gazet inviting objections and suggestion in regard to the proposal for declaring the above monument as a protected one as required under sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act 1966, (Tamil Nadu Act 25 of 1966). It was also notified an extent of 19.545 Hectares adjoining the cave temple and sculptures at Chinna Ivar Malai as a 'Prohibited area' under Rule 32 of Chapter VII of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Rules 1971. No objection or suggestions have been received either by the Government or by the Director of Archaeology, Madras. The Director of Archaeology has therefore requested the Government to issue Notification declaring the aforesaid monument as a 'Protected monument' under sub-section (1) of section 3 of the said Act and the adjoining areas of the monument as a 'Prohibited area' under rule 32 of Chapter VII of the said rules.

2.The Notifications annexed to this order will be published in the Tamil Nadu Government Gazette. The Works Manager, Government Printing, Madras is requested to supply 10 copies each of the Gazette containing the Notifications to the Government and to the Director of Archaeology, Madras-28.


