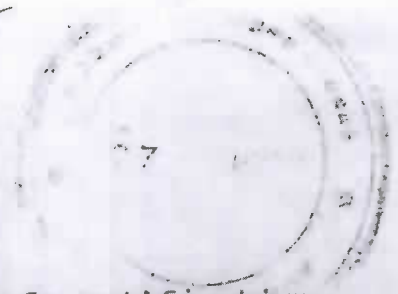

In the government orders read above, Notification were published declaring certain monuments as 'Protected monument' under sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966 (Tamil Nadu Act 25 of 1966). It was also ordered declaring adjoining areas of certain monuments as 'Prohibited area' under rule 32 of Chapter VII of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Rules, 1971, No objections or suggestions has been received either by the Government or by the Director of Archaeology, Madras, the Director of Archaeology has therefore requested the Government to issue Notification declaring the aforesaid monuments as 'Protected Monument' under sub-section (3) of the said Act and the areas adjoining the monuments as Prohibited areas under rule 33 of Chapter VII of the said Rules.

2. The Government accept the suggestion of the Director of Archaeology and approve the draft Notifications annexed to this order. Notifications will be published in the Tamil Nadu government gazette, The Works Manager, Government Press, Madras is requested to arrange for publication of the Notifications in the next issue of the Tamil Nadu government gazette and supply of 10 copies of the gazette Notification to the government and to the Director of Archaeology, Madras-2
