In the Government order first read above, a notification was approved inviting objections and suggestions for declaring the Highways and Rural Works Department land surrounding Historical Monuments in Pannai Village, Mambalam-Guindy Taluk, Chennai District as an Archaeological Site and Remains under sub section (1) section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966 (Tamil Nadu Act. 25 of 1966). No objection or suggestion has been received either by the Government or by the Commissioner of Archaeology, Chennai. The Commissioner of Archaeology in his letter second read above has, therefore, requested the Government to issue notification declaring the above said Archaeological Site and remains as a protected Monument under sub section 3 of section 3 of the said Act.

2. The Government approve the proposal of the Commissioner of Archaeology Department and the draft notification under sub-section (3) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966 (Tamil Nadu Act 25/1966).

3. The Notification appended to this order published in the Tamil Nadu Government Gazette.

4. The Works Manager, Government Central Press, Chennai is requested to publish the notification to this order in the Tamil Nadu Government Gazette and send 5 copies of the Gazette notification to Government and the Commissioner of Archaeology, Chennai-600-113.

NOTIFICATION

WHEREAS, the Government of Tamil Nadu are of the opinion that the ancient monument specified in the Schedule below requires protection under the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966 (Tamil Nadu Act 25 of 1966)

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 3 of the said Act, the Governor of Tamil Nadu hereby gives two months notice of his intention to declare the said ancient monument to be a protected monument.

Notice is hereby given that the proposal will be taken into consideration on or after the expiry of the said period of two months from the date of publication of the Notification in the Tamil Nadu Government Gazette, and that any objection which may be received from any person interested in the said monument before the expiry of the said period will be considered by the Government of Tamil Nadu. Objection if any, should be addressed to the Secretary to Government, Tamil Development-Culture and Religious Endowments Department, Chennai 600 009.
