ORDER

In G.O.No. 1586 Education dated 20.8.78 a Notification was approved inviting objections and suggestions for declaring the Vittala Temple at Vittalapuram in Channarayana District as a protected monument as required under sub-section (1) of Section 3 of the Tamil Nadu Ancient Monuments and Archaeological Sites and Remains Act, 1987. No objection or suggestion has been received either by the Government or by the Director of Archaeology Madras. The Director of Archaeology has therein requested the Government to issue Notification declaring the aforesaid monument as "Protected Monument" under section (3) of the said Act.

2. The Director of Archaeology has accordingly submitted a draft notification under section 3 (3) of the said Act. The Government accept the proposal of the Director of Archaeology and approve the draft Notification submitted by him.

3. The Notification appended to this order will be published in the Tamil Nadu Government Gazette. The Works Manager, Government Press, Madras is requested to supply 5 copies of the Gazette Notification as published in the Tamil Nadu Government Gazette each to the Government and the Director of Archaeology, Madras.
