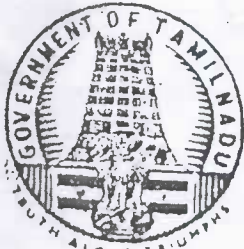

Variation to list of parks within the jurisdiction of Tambaram Municipal Council.

(G.O. Ms. No. 73, Municipal Administration and Water Supply, 4th February 1985.)

No. II (2)/MA/1186/85.—In exercise of the powers conferred by sub-section (1) of section 5 of the Tamil Nadu Parks, Play-fields and Open Spaces (Preservation and Regulation) Act, 1959 (Tamil Nadu Act 26 of 1959), the Governor of Tamil Nadu hereby makes the following variation to the list

of parks in the area within the jurisdiction of the Tambaram Municipal Council approved and published with the Education Department Notification No. 90 of 1968, dated the 21st May 1968, at pages 616-617 of Part II—Section 3 of the Fort St. George Gazette, dated the 4th September 1968, the draft of the same having been previously published as required by sub-section (2) of section 5 of the said Act.

No. II (2)/REV/1187/85.—Under clause (5) of section 3 of the Tamil Nadu Land Reforms (Fixation of Ceiling on Land) Act, 1961 (Tamil Nadu Act 58 of 1961), the Governor of Tamil Nadu hereby makes the following amendemnt to the Revenue Department Notification II-1 No. 4316 of 1962, dated the 10th September 1962, published at pages 174-175 of Part II—Section 1 of the Fort St. George Gazette, dated the 12th September 1962 as subsequently amended:

Declaration of certain monument in North Arcot district as Protected monument under Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act.
