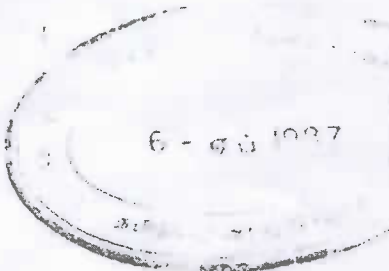

Order

In the Government Order No. 73 above, the Government has orders approving the proposal of the Director of Archaeology in declaring the Chalukyan temple in Valluvar village, Arakonam Taluk, North West District as a protected monument and the notification for publication in the Tamil Nadu Government Gazette inviting objections and suggestions in regard to the proposal declaring the above monument as a protected monument as required in sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act, 1966, (Tamil Nadu Act 25 of 1966). No objection or suggestion has been received either by the Government or by the Director of Archaeology, Madras. The Director of Archaeology has therefore requested the Government to issue a notification in the Government Gazette declaring the above monument as a protected monument under sub-section (3) of section 3 of the Act and to publish the draft notification accordingly. The Government has approved the proposal of the Director of Archaeology and the draft notification submitted by him.

3. The notification annexed to this order will be published in the Tamil Nadu Government Gazette. The Director, Government Press, Madras is requested to supply 5 copies of the Gazette notification to be published in the Tamil Nadu Government Gazette to the Government and to the Director of Archaeology, Madras.




ANNEXURE
