In the Government Order read above the Government issued orders moving the proposal of the Director of Archaeology (in-charge) declaring the rock paintings at Keelavalai Village, Thirukkovilur Taluk, South Arcot District as a protected monument and the notification for publication in the Tamil Nadu Government Gazette. Also objections and suggestions in regard to the proposal for declaring the rock paintings at Keelavalai Village, Thirukkovilur Taluk, South Arcot District as a protected monument, as required by sub-section (1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Relics Act, 1966 (Tamil Nadu Act 25 of 1966). No objection or suggestion has been received either by the Government or by the Director of Archaeology, Madras. The Director of Archaeology has therefore advised the Government to issue Notification declaring the said monument as a "protected monument" under sub-section (1) of the said act and has submitted a draft notification accordingly. Government approve the proposal of the Director of Archaeology and the draft Notification submitted by him.

The Notification annexed to this order will be published in the Tamil Nadu Government Gazette. The Works Manager, Government Press, Madras is requested to supply 5 copies of the Gazette Notification as published in the Tamil Nadu Government Gazette to the Government and to the Director of Archaeology, Madras.



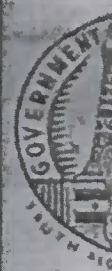

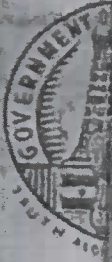
