ORDER:

In the Government order read above the Government issued orders approving the proposal of the Director of Archaeology Department for declaring Perangiyur Thirumoolanathar Temple, Ulunthurpet Taluk, Villupuram Remasamy Padayachiar District as a protected monument and the Notification for publication in the Tamil Nadu Government Gazette, inviting objections and suggestions regarding the above monument as a protected one as required under sub-section(1) of section 3 of the Tamil Nadu Ancient and Historical Monuments and Archaeological Sites and Remains Act 1966 (Tamil Nadu Act XXV of 1966). No objection or suggestion has been received either by the Government or by the Director of Archaeology Department, Madras. The Director of Archaeology Department has therefore requested the Government to issue Notification declaring the aforesaid monument as a 'protected monument' under the sub-section (3) of section 3 of the said Act and has submitted a draft notification accordingly.

2. The Government approve the proposal of the Director of Archaeology Department and approve the draft notification submitted by him.

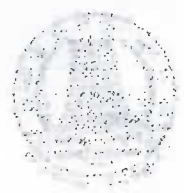
